MECHANISM OF SKIN AGEING : **FOCUS ON THE EYE CONTOUR AREA**

The passing of time leaves inevitable signs on the skin but not all areas of the face are affected in the same way. The eye contour area is one of the most fragile zone of the face, and one of the first places to show signs of ageing. Taking care of the eyes is an indispensable step in maintaining youthful-looking, healthy skin.

The eye contour skin is particularly thin. Fine lines are printed quickly under the effect of blinking and muscle contractions throughout facial expression. As well, the decrease of the skin microcirculation leads to less drainage and the installation of signs of fatigue.

The 5 types of defects that appear in the eye area:

- 1 WRINKLES
- 2 SKIN SAGGING
- 3 LACK OF RADIANCE
- 4 DARK CIRCLES
- 5 PUFFINESS

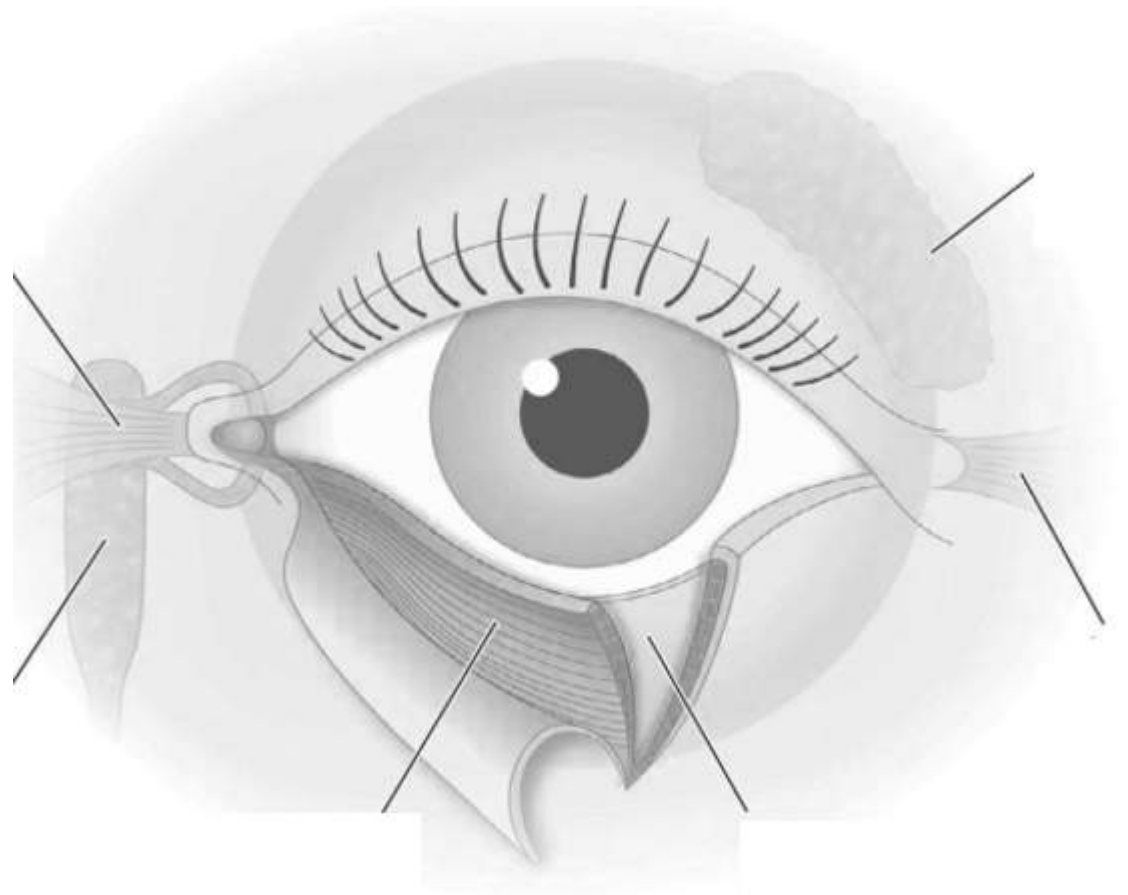

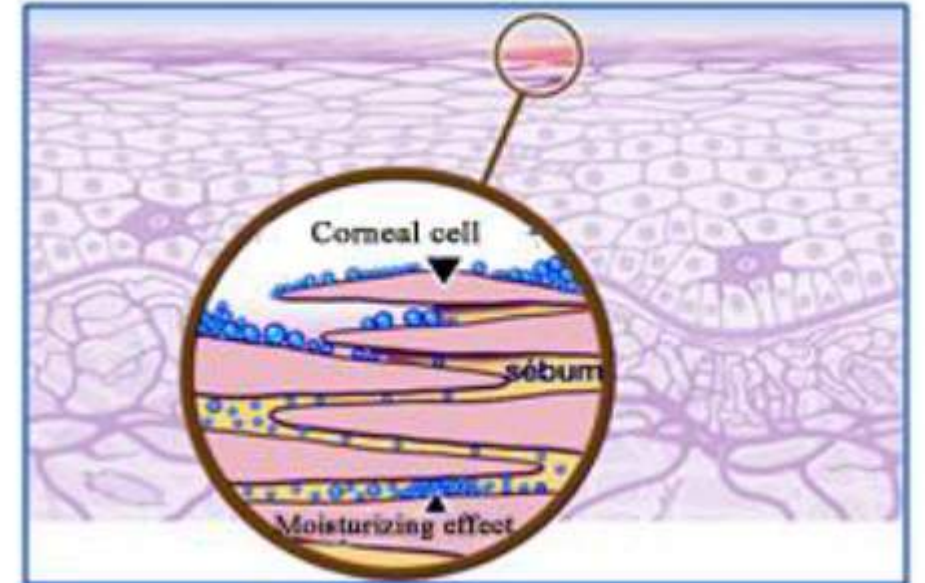


LACK OF HYDRATION

Hydration is a complex phenomenon, which is essential to maintaining soft, smooth and toned skin. Water can be brought in by blood circulation and stored in the dermis, it is the skin's true « reservoir », but as the epidermis is vessel-free, it is recommended to be brought in by cosmetic products.

Water is needed for the renewal of the epidermis cells. If this renewal cycle is disturbed, the skin quality is directly altered: it looks dull, lacks suppleness and dehydration striae may appear; an oily and dehydrated skin will become grainy and will tend to flake.

The causes of dehydration are numerous: genetic causes, seasonal & environmental factors like wind & cold, chemical agents, stress, sun, hard water, hormonal changes, unsuitable cosmetics...etc. However, ageing is the main cause. From a certain age, the basic structure of the dermis changes, the hydration rate of the stratum corneum decreases, thus increasing the signs of ageing.



EYEBAGS

There are two types of eyebags: aqueous eyebags and fatty eyebags.

The main causes of these eyebags are:

Water retention: as the skin of the eyelids is four times thinner than that of the rest of the body, water tends to accumulate in these more delicate areas.

Slowing down of the blood and lymph circulation.

Fatty deposit under the skin of the lower eyelid.

Skin slackening due to skin ageing.

Lack of sleep, tiredness.

Stress.

Heredity.

Consequently, they can be seen in young people, and sometimes as early as the age of 20. To reduce the eyebags, lymph circulation must be fostered through draining and hydration and skin elasticity must be fostered using cosmetic products.

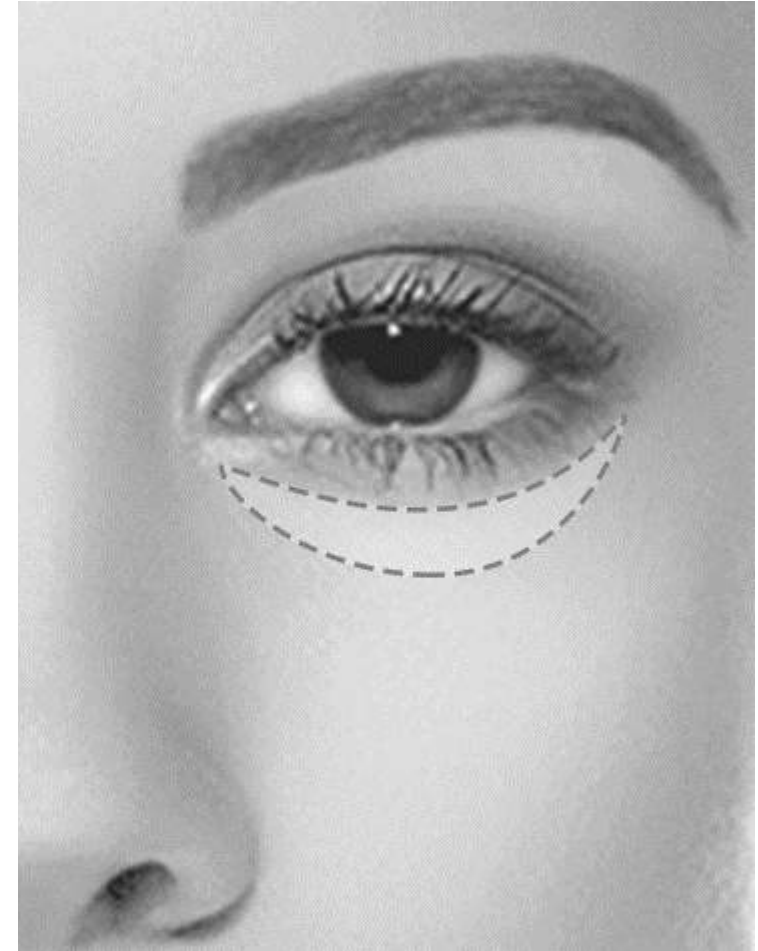


DARK CIRCLES

Dark circles are caused by a deficiency in return circulation: blood pigments accumulate in the connective tissue, giving the skin this particular dark colour.

Temporary dark circles appear at the end of the day and correspond to a vascular congestion.

Permanent ones come from a hyperpigmentation of the skin, often hereditary. They are always accentuated by fatigue, insomnia, stress, alcohol abuse and smoking.



WRINKLES & FINE LINES

As part of the ageing process, the skin changes, loses its natural moisture and its fundamental substance decreases. Because of a lack of moisture and nutrients, the production of collagen reduces. This « support mattress » for the skin gets weaker, loses tonicity and firmness. The cohesion between the dermis and the epidermis then becomes weaker. In addition, the repetitive muscle contraction has a remarkable effect. So on the surface, skin depressions appear these are wrinkles.

Two categories of wrinkles can be observed:

- the expression lines on the forehead, between the eyebrows, at the level of crow's feet, the nasolabial folds and the corners of the mouth

- the weakening lines linked to skin sagging, loss of tonicity and firmness of the skin. They are responsible for altering the oval of the face, for upper eyelid, bags under the eyes and the double chin.

Wrinkles are due to mechanical stress, skin dehydration, reduction in the production of collagen and elastin and also their quality, environmental reasons (free radicals, cold, pollution, UV), hormonal changes, tobacco, alcohol, lifestyle, but also the genetic programme of each individual.



LOSS OF FIRMNESS, SAGGING

Over time, the face undergoes an overall sagging, the balance of the face is modified by the action of gravity.

Through the effect of gravity, sagging is observed of the dermis, of the fat and of the muscles and weakening is observed of the venous and lymphatic microcirculation, all of which lead to pseudo-volume on the lower part of the face.





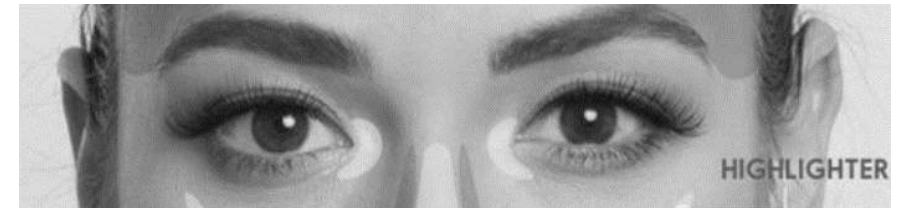
RADIANCE & ANTIFATIGUE EFFECT

Radiance is the manner in which the skin reflects and diffuses light. The smoother the skin, the more it will reflect the light : like any surface, any unevenness, such as wrinkles, imperfections or rugosity, breaks and reduces the reflection.

But, regarding the skin, the light is also reflected by the deepest layers of the skin because the light penetrates there by transparency.

Consequently, in order to be radiant, skin must firstly be healthy, well hydrated, in good condition and homogenous looking because it will then be transparent and clear.

Tobacco, unhealthy lifestyle, tiredness, skin dehydration, ageing, pollution, extreme sun exposure,...all these factors damage our skin and the complexion becomes dull.

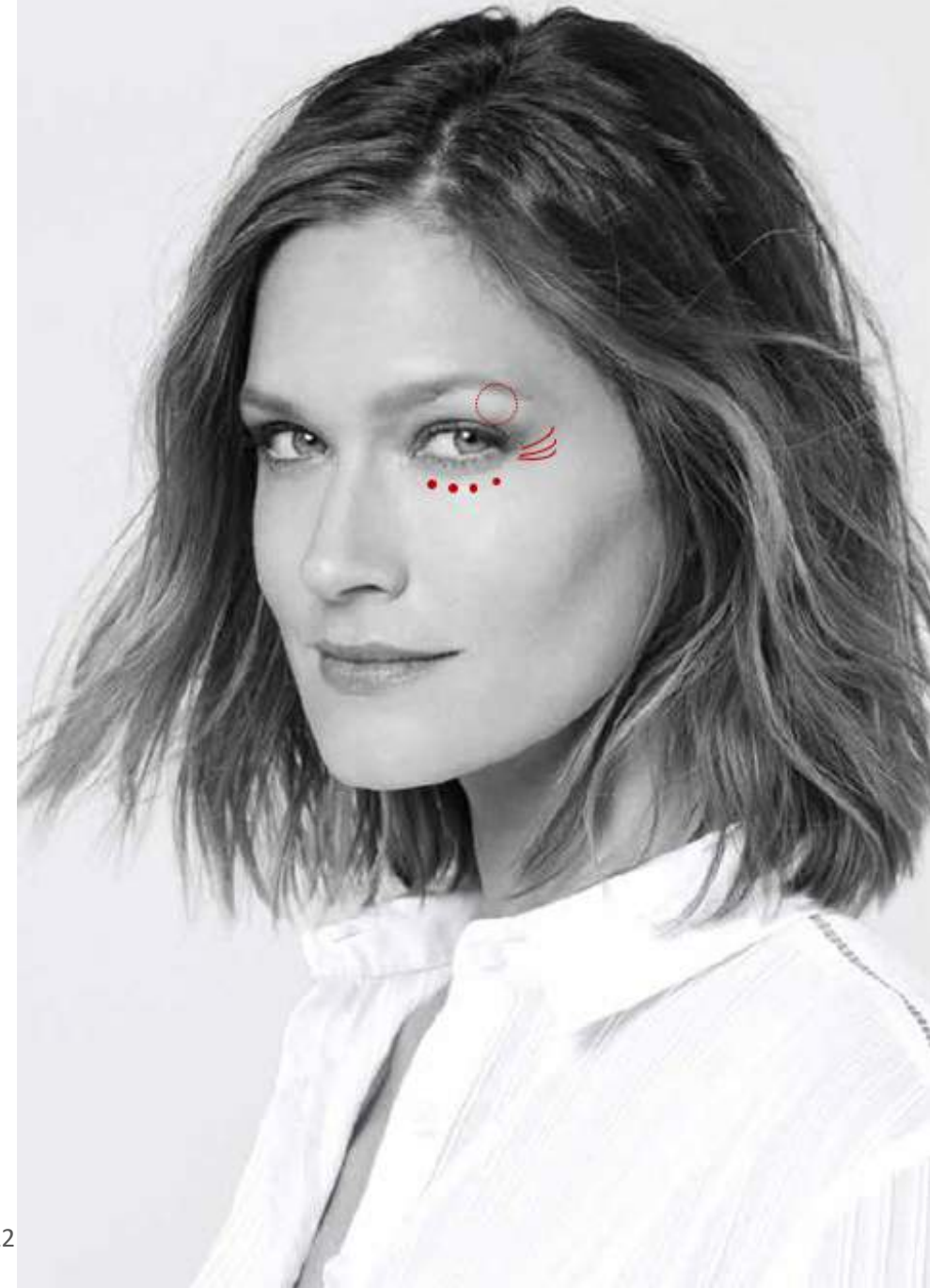

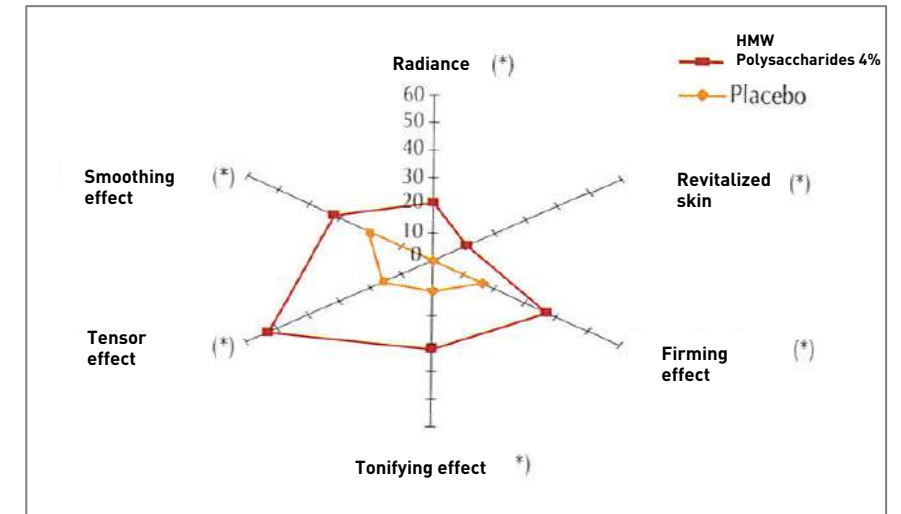

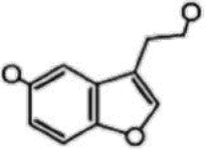

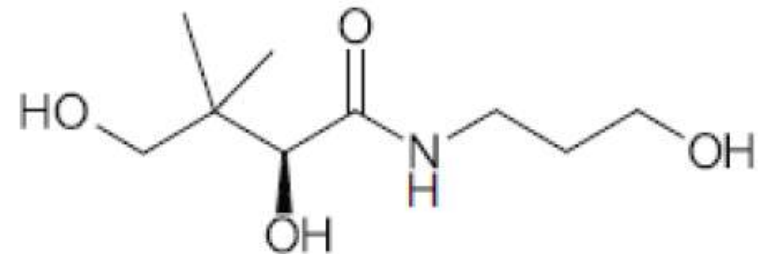
A leading moisturizer that keeps the skin feeling soft and maintain its elasticity.

CLINICAL STUDIES*

PANEL :

- Number of subjects : 18
- Age : 66 years old on average
- Measurement areas: Eye contour

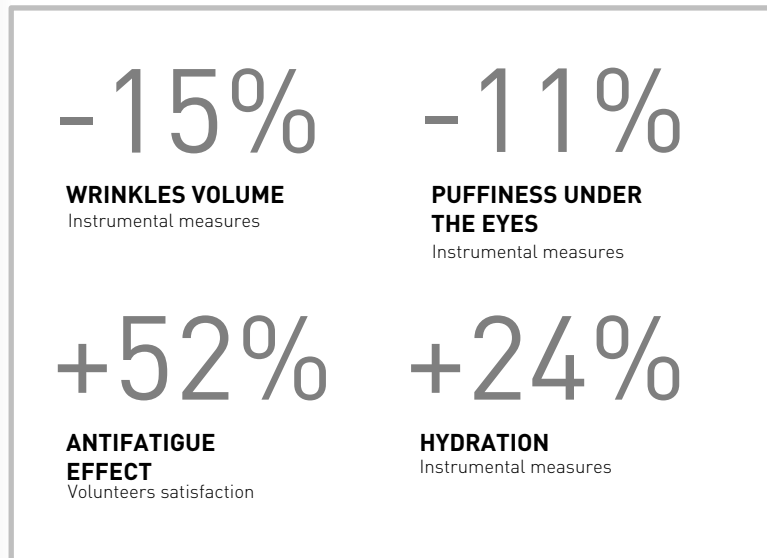

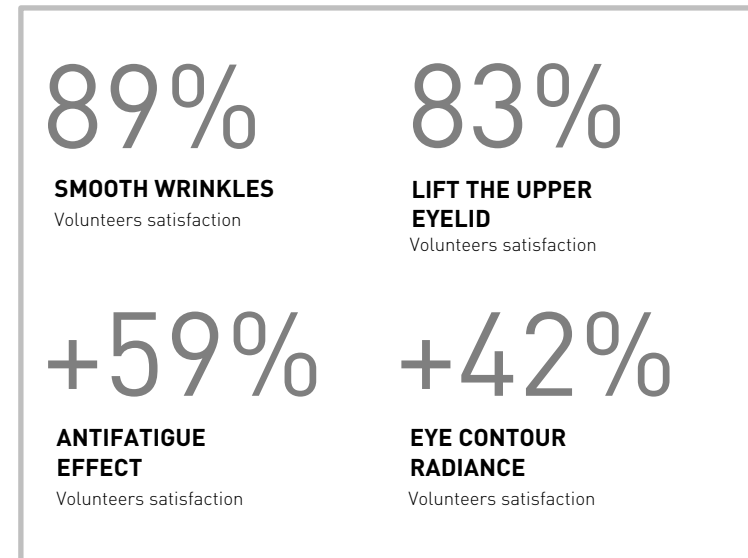
